Jim Bauer - RTK

Jim Bauer – The Solicitor's bill for September 2023 for general work was \$8,623.30 and the RTK Solicitor bill for September 2023 was \$11,935.00. We just wanted everyone to be aware of these numbers.

Jim McGraw- While we are on the RTK request, both the administrative time and our time related to these requests there have been some conversations regarding it, this is why we did the break out of the invoice.

Jim McGraw- Two weeks ago there was a meeting of the Washington County Association of Township Officials, two months ago this Board approved a Resolution regarding RTK requests for presentation to that body at their meeting, which related to our request, that the association with its greater power and influence within State Government that they adopt our Resolution requesting that they pursue some Legislative changes of the RTK Law, not to restrict anyone access to publicly available information, but to

address the process, the way the process can be abused and create additional costs, we were confident that this was not just happening to Donegal Township that it is happening across the State.

Jim McGraw – This RTK Resolution was the only proposed Resolution to be adopted by that body at their annual meeting. They put a copy on all the tables and they asked us to address the Resolution to discuss it and explain why we thought it was important. We did that and they then put it to a vote and it passed unanimously. We got positive feedback afterwards. We acknowledge that we don't have all the perfect answers but the collective influence of this group and the collective influence of that group is a start to move things in a positive direction to reduce the passive costs when there are a significant number of RTK requests being presented to a municipality. This was adopted and we are going to work along with them to further their legislative efforts, we thought it was a positive step to have all the Township's in Washington County on board with our line of thinking about ways of reform to the law.

OLD BUSINESS:

1. Tunnel Ridge proposed public waterline along Old National Pike and Toll Gate Road.

Jim Bauer - Is there anything new that we can discuss at this time?

Ed Shingle – This will go along with #1 New business.

Eric Graham- How much does a tower cost?

Ed Shingle – A quarter of a million. The Engineer could approve a smaller one with a pump. I asked the Engineers to come up with options and he came up with a Tank, a Pump, a Tank/Pump combination.

Eric Graham – how many gallons is the tank we have now. Ed Shingle, I don't remember.

Kathy Croft – It is not huge. This doesn't have to be a huge water tower it can be a tank.

Ed Shingle – It doesn't need to be the size of the one we have now.

Jim Bauer – Okay we are still working on this; we need to have a meeting with them.

2 McAdoo Pump Station Fuel – (Propane, Diesel or Gasoline)

Ed Shingle – I think we need to tell Tunnel Ridge that we want Natural Gas.

Randy Polan- Yes, gasoline and diesel can become stale and will we get refills when and if we need it.

Jim Bauer - We will need to talk to them about this when we are talking about the water line.

NEW BUSINESS:

1. Rich Hunter – Private water line in Township Right of Way.

Ed Shingle made the motion to table. Jim Bauer second. Motion Carried 3/0.

2. Roberts Subdivision Plan – (N. Liberty Street and Carrie Drive)

Ed Shingle made the motion to approve the Roberts Subdivision Plan. Randy Polan second. Motion Carried 3/0.

3. Smith Subdivision Plan – (1274 & 1276 State Route 40 West)

Jim Bauer – we need some legal documentation on what the alley is or isn't. We can't do anything until we know about the alley.

Jim Bauer made the motion to deny approval of the Smith Subdivision as presented. Ed Shingle second. Motion Carried 3/0.

Jim McGraw – The bulleted items that are here are information items before we decided to vote to approve it. Since the motion was approving the submission. We don't necessarily have to identify on the agenda what those items need to be.

Ed Shingle – this is more for the paperwork that Jamie is going to send to them.

Jamie Schaller - They wanted us to come up with four projects for them to look at because a lot of times the 2 or 3 projects don't qualify.

Ed Shingle- they wanted three or four but he could get five, right?

Jamie Schaller - Yes.

Ed Shingle – we could phrase is as a substation that way it covers a water tank or what ever else it could be.

Ed Shingle changed his motion to be:

Ed Shingle made the motion to approve submitting five projects the Washington County Redevelopment Block Grant. Randy Polan second. Motion Carried 3/0.

Jim Bauer – We are caught up on the Pension Plans but we had to pay some interest and these are on the unpaid bill lists so this is an FYI.

Jamie Schaller - This was from the 2017-2020 Audit.
